An emergency public meeting of the Board of Directors (the "Board") of the Noah Webster Schools-Mesa, an Arizona non-profit corporation (the "Corporation" or the "School"), was held in the school's Corporate Conference Room at 5399 N. Pima Rd, Scottsdale, Arizona at 7:30 a.m.. A quorum being present, and the meeting having been duly noticed and called, the meeting was called to order.

1. Call to Order

The meeting was called to order.

2. Review and Approve the Loan Document Related to the School's Participation in the CARES Act Paycheck Protection Plan

Director R. Miller gave the Board background information regarding the PPP loans, the requirements to qualify and what will need to be submitted for loan forgiveness. The Board reviewed the actual loan documents and had specific questions. Director Miller informed the Board that the school had received legal opinion from the school's attorney and also spoke with the underwriter for the 2015 IDA Bond, both saw no issues with the school participating. the underwriter explained that he had multiple charter schools nationwide applying and that with the economic outlook being so unstable, the possibility of COVID 19 interfering in operations next school year is quite high.

The Board further discussed the additional work the staff has been required to do during this time and the effort in several areas that is above normal business day requirements. With no further questions, Director R. Miller made the following motion:

To approve the loan as presented and allow Vicki Dry to sign documents as needed and to give management approval to give employees who are continuing to work and to put additional effort into providing services a stipend for their supplemental endeavors.

Director R. Tomasson seconded the motion.

The motion passed unanimously with Directors Pennington, Wales, Tomasson, R. Miller and S. Miller all voting to approve.
