Dear Noah Webster Families,

Effective Monday, January 4, 2021 Noah Webster Students, KG-6th will be returning to distance learning. All students at both schools will be instructed via the distance learning model with their current teachers from January 4-15, 2021. During these two weeks, we will re-establish our school-level situation with the county and re-evaluate area and zip code metrics, to confirm a return to our current modified model of both in-person learning as well as distance learning on Tuesday, January 19, 2021. Noah Webster Schools will be offering on-site support for students. Starting Monday, January 4, 2021, Noah Webster Schools will be implementing the following:

- Supervision will be provided for students (Kindergarten 6th grade) who do not have a caregiver at home. This may include children of first responders and/or essential workers.
- Noah Webster will have designated classrooms, music rooms or multipurpose spaces for registered students to be supervised as they complete their online coursework.
- There is no recess, in-person specials such as Music/PE, or direct instruction provided. All instruction is through the on-line distance learning platforms.
- Families must supply their own transportation to and from campus.
- Monday Friday 8:30 am 3:00 pm (drop off at 8:15 am, pick up promptly at 3:00 pm)
- Early Release Days 8:30 am 1:00 pm (pick up promptly at 1:00 pm)
- There is no before or after school care provided.
- Students are required to bring headphones to complete their school work.
- In correlation with our mitigation plan and strategies, we highly suggest students only stay on campus for the minimal amount of time necessary to complete distance learning classwork as there is limited space and staff members available.
- Staff servicing students such as English Language Learners (ELL), Special Education, Title I, etc. may align in-person support with digitally provided support at times.

Please note registration for the On-Site Support Services Program will open on Friday, December 11, 2020. For instructions on how to complete the program application, please visit our website (www.noahwebster.org) and select "On-Site Support Services" under the Distance Learning section in the Academics menu. Interested students must register for On-Site Support Services by Wednesday, December 16 at 3:00 p.m. Please note only students that are enrolled in the program will be eligible to attend.

## On Site Support Services 2020-2021

### **Overview**

- In an effort to adhere to local health guidance as well as ensure we have adequate staff available to supervise all onsite supports:
  - Mesa campus registration will be limited to 70 students.
  - Pima campus registration will be limited to 55 students.
- Should the campus reach capacity, an expansion plan will be put in place based on staff availability.
- Program hours are 8:30 am to 3:00 pm., with student drop off at 8:15.
- Families will need to provide transportation.

### **Student Expectations**

The following expectations and guidelines will be followed:

- Students are expected to behave in a way that ensures the safety of themselves and other students.
- Students are expected to follow all health and safety expectations.
- Students are expected to behave in a way that does not disrupt the learning of other students.
- If a program specialist, supervisor or campus administrator determines that a student cannot benefit from onsite support or follow expectations, the student may be withdrawn from the on-site program.
- Extreme behaviors, disrespect to staff, attempts to leave campus without permission will accelerate the disciplinary process.

### Parent Expectations

All parents must adhere to the expectations below:

- Parents will register their child(ren) for onsite support.
- Parents will not send their child(ren) to onsite support if their child was not registered.
- Parents will ensure their child(ren) completes a home health screening prior to arrival.
- Parents will ensure all students are picked up by 3:00pm.
- If a child has specific health needs or requires medication, parents must contact the school health office prior to beginning onsite support.
- Any adult picking a child up from onsite support will bring an ID and be prepared to show it during the pick-up process.

#### Safety measures

A mitigation plan has been developed in an effort to reduce the spread of COVID-19. The details of that plan are as follows:

- There is a maximum of students registered per campus. Mesa Campus -70 Pima Campus -55
- All attendees must be registered prior to the deadline in an effort to ensure all campuses may create rosters with assigned locations for all student and staff.
- Hand sanitizer will be located within each instructional space. Students will wash hands and/or sanitize frequently.
- All staff will wear face coverings when students or other staff are present.
- All students are required to wear face coverings.
- Nurse or Health Assistants will be present during regularly scheduled hours.
- High touch surfaces will be cleaned and disinfected regularly.
