

November 14, 2023

A public meeting of the Board of Directors (the “Board”) of Noah Webster Schools-Mesa, an Arizona non-profit corporation (the “Corporation”), was held virtually at 4:30 P.M. A quorum being present, and the meeting having been duly noticed and called, the meeting was called to order.

- Approval of the Minutes of the October 10, 2023 Board Meeting

The Board reviewed the minutes of the October 10, 2023 Board meeting. Director Tomasson made a motion to approve the minutes as presented. Director Pennington seconded the motion.

The motion passed unanimously with Director Tomasson, Director Pennington, Director S. Miller and Director Wales voting to approve.

- Specific Matters to be Considered

- Review of the 9/30/23 Internally Generated Financial statements and Related Documents

Vicki Dry began the discussion by explaining the negative impact low enrollment has had and the financial issues being faced. Director S. Miller discussed the effect the low enrollment has had on covenant compliance and cash on hand. Although we continue to be in compliance, we definitely need to increase enrollment to help ease cash flow issues and help with our financial health overall. She indicated that we needed to implement some changes to our processes both financially and with marketing.

- 2022-2023 A-F Letter Grade Overview

Principal Friedermann reviewed documents previously provided to the Board regarding the 2022-2023 A-F Letter Grade. She discussed the components that made

up the Grade Letter B that Mesa received. She also focused on EL proficiency and growth. Ms. Friedermann further explained Acceleration Readiness Data and Bonus Point and how these areas affected Mesa's overall grade. She provided the Board with an Accountability Overview and Competing School Comparisons. Director Tomasson asked for an explanation of how the range for competing schools was decided and Director Miller noted that it was initially implemented for the marketing survey that was done when bonds were first issued.

- SPED Program Updates

Principal Friedermann reviewed SPED program numbers along with changes being implemented this year for not only Special Education but for EL students as well. She reviewed a breakdown of the number of students with IEPs and speech only and reviewed EL proficiency as it relates to the A-F Letter Grade.

- 7<sup>th</sup> & 8<sup>th</sup> Grade Updates

Principal Friedermann reported that to date the school has a pre-enrollment of 24 students for FY25 7<sup>th</sup> Grade for Mesa and 11 for Pima. She reported that the schools are continuing to promote the 7<sup>th</sup> grade to its families and current students. She indicated that the committee has narrowed down curriculum choices and pricing and has met with involved departments to map out and consider what will need to be done to accomplish the physical moves on campus necessary to separate the older students from the younger students. Mesa is planning on having 5<sup>th</sup> through 8<sup>th</sup> upstairs and Kg through 4<sup>th</sup> downstairs. Pima will be looking at 4<sup>th</sup> through 8 upstairs and Kg though 3 downstairs. Numerous classroom moves will be necessary this summer to ensure this configuration is completed.

Ms. Friedermann also indicated that she is working with Canyon Athletic Association leagues to ensure both Noah Webster Schools can participate in organized athletics. Along with athletics the committee is reviewing possible electives for FY24.

- School Updates

Principal Friedermann reviewed the progress the schools have had with furthering Family Engagement. She reviewed Boo Fest, Grade Level Performances and Trivia Night. She indicated that these were all part of our push to increase enrollment. She also informed the Board that in trying to promote better attendance, a FREE assembly, Our Fragile Planet, will be presented to those students who have earned it through their good attendance. Because of the assembly, Mesa saw 89% of the total school population meet the 90% attendance criteria for the 4 week measurement period and Pima saw 83.33% of its total school population meet the criteria.

Principal Friedermann informed the Board that that both she and Principal Rodenbaugh would be forwarding all required performance documentation to the Principal Evaluation Committee for review prior to their assessment.

- Announcements

There were no announcements. The next Board meeting was set for December 13, 2023 at 4:30 pm.

- Adjournment

There being no further business, Director Pennington made a motion to adjourn the meeting. Director Wales seconded the motion.

The motion to adjourn the meeting at 6:15 pm passed unanimously with Director Pennington, Director Tomasson, Director Wales and Director S. Miller voting to approve.
