A public meeting of the Board of Directors (the "Board") of Noah Webster Schools-Mesa, an Arizona non-profit corporation (the "Corporation"), was held virtually at 4:30 P.M. A quorum being present, and the meeting having been duly noticed and called, the meeting was called to order.

# Approval of the Minutes of the May 14, 2024 Board Meeting

The Board reviewed the minutes of the May 14, 2024 Board meeting. Director Tomasson made a motion to approve the minutes as presented. Director S. Miller seconded the motion.

The motion passed unanimously with Director S. Miller, Director R. Miller, Director Pennington and Director Tomasson voting to approve.

#### Specific Matters to be Considered

# Review Internally Generated Financial statements and Related Information for March 31, 2024

Discussion took place regarding the decrease in revenues and corresponding decrease in expenses as was presented at an earlier Board meeting. Director Tomasson recognized that the main cause for the current shortfall is the decreasing enrollment that the schools have seen. Director S. Miller brought up current enrollment, and reviewed the wait list which is showing growth for next school year. She reviewed certain covenant compliance issues that the Board must be aware of and continue to take into consideration when discussing the financials or budgets.

As discussions continued, Director S. Miller spoke about the many on-going marketing initiatives and how these initiatives are being implemented, Director Pennington inquired about asking our current parents why they are staying with us. Principal Friedermann explained our new project which askes students and teachers to either write or draw why they love Noah Webster. Once done, we will be posting on facebook and hanging in the multipurpose room and in the front office.. The Board requested that e-mails be sent to current parents asking the question why do you like Noah Webster and what can we do to make it better. It would be good to get these out by the first part of June. Ms. Friedermann explained to the Board that we

are currently passing out not cards to parents when they come in the office or after an event asking what they like about the school and what could the school do to improve.

# • Community Eligibility Provision (CEP) & Related

The Board was presented with information regarding The Community Eligibility Provision which is a non-pricing meal service option for schools and school districts that serve low-income populations. Ms. Dry summarized the possible reimbursement totals for the school and reviewed the benefits of all students having access to free breakfast and lunch during the week. Discussion took place with everyone seeing the benefits to the students but also possible benefits to the school in way of increased enrollment. Ms. Dry also provided the Board with information on St. Mary's Food Bank's Backpack Program. This program will provide free food on weekends for identified students.

#### School Updates

- Enrollment With enrollment being discussed in depth earlier, Ms.
   Friedermann just commented that we are continuing to have tours scheduled and will be staying on top of things during the summer break.
- o 7<sup>th</sup> Grade Updates Ms. Friedermann explained that there was nothing new to report on. Implementation of the plans previously discussed is ongoing.
- o Marketing Updates Ms. Christine Haas reviewed recent, current and upcoming marketing initiatives and events with the Board.
