A public meeting of the Board of Directors (the “Board”) of Noah Webster Schools-Mesa, an Arizona non-profit corporation (the “Corporation”), was held virtually. A quorum being present, and the meeting having been duly noticed and called, the meeting was called to order.

- Approval of the Minutes of the Board Meeting

The Board reviewed the minutes of the April 22, 2025 Board meeting. Director Tomasson made a motion to approve the minutes as presented. Director Pennington seconded the motion.

- Review and Adopt the FY25 Annual Expenditure Budget Revision 1

Ms. Dry had provided the Board with a copy of the FY25 Annual Expenditure Budget Revision 1. She explained the revisions and the data changes to the budget. The Board discussed the revisions and had no further questions.

A motion to approve Revision #1 of the FY25 Annual Expenditure Budget as presented was made by Director Tomasson and seconded by Director Pennington

The motion passed unanimously with Director Tomasson, Director S. Waldrop, Director S. Miller, Director Wales and Director Pennington voting to approve the motion.

- Update and Discussion of Marketing and Enrollment

Director S. Miller explained to the Board some of the steps being taken to increase community engagement and enrollment. She stated that although this was happening at both campuses, a larger focus was being placed on the Pima Campus. She reviewed the letter being put together that will be sent to local business managers to explain the benefits of the schools and to offer up the possibility of a meeting with Board members to further discuss the positives to their employees. Directors Tomasson and Waldrop said they would like to take part in any meetings set. In addition, Director Miller discussed meeting with the DEVCO representative to “Pick

her brain” on the current businesses in the DEVCO plaza and their management contacts. She indicated that Ms. Dry would be doing the initial contact to get a time to meet.

Director Tomasson requested that a draft copy of the letter we’re intending to send be circulated to the Board for review and possible additions.
