A public meeting of the Board of Directors (the “Board”) of Noah Webster Schools-Pima, an Arizona non-profit corporation (the “Corporation”), was held virtually. A quorum being present, and the meeting having been duly noticed and called, the meeting was called to order at 4:30 pm

- Approval of the Minutes of the Board Meeting

The Board reviewed the minutes of the August 27, 2025 Board meeting. Director Tomasson made a motion to approve the minutes as presented. Director S. Miller seconded the motion.

- Review and Approval of the FY25 Annual Financial Report to the State
